Violence is the use of any force to compel another person to do something; to embarrass; to take away freedom; to annoy; to prevent another person from carrying out his or her will, leading to constant threats, assaults, or even death.

WHAT IS VIOLENCE AGAINST WOMEN?

Gender violence

Relationship of male domination and female obedience, where men tend to control the women's desires, opinions, and rights.





Domestic violence

Violence that occurs within the home, in relationships between people in one's own family.

Intimate Partner Violence

Violence in couple relationships, occurs inside or outside the home, also occurring with expartners or ex-cohabitants.



WHAT ARE THE **TYPES** OF VIOLENCE AGAINST WOMEN?

Moral violence

This is considered any conduct that amounts to lying, falsehood, or insult.

Examples: Accusing the woman of cheating in a lying way; making lying criticisms and exposing the woman's intimate life.





Understood as any conduct that constitutes removal, partial or total destruction of objects, work instruments, personal documents, property, values and rights or economic resources, including those destined to meet their needs.

Examples: Excessive control of money; failure to pay alimony; destruction of the woman's documents and objects.





Psychological violence

Actions or omissions that demean, dominate, humiliate, controlling acts, behaviors, beliefs, and decisions.

Examples: Threatening the woman, children or family; manipulating the woman; forbidding the woman to talk to friends and relatives; constant surveillance; stalking and blackmail.

WHAT ARE THE **TYPES** OF VIOLENCE AGAINST WOMEN?



Physical violence

Use of physical force that results in suffering, death, psychological harm, impaired development, or any kind of absence.

Examples: Spanking; throwing objects; shaking and squeezing of arms; strangulation or suffocation; injury with sharp objects; injury from burning or firearms, and torture.



Sexual violence

Act of force in which the aggressor forces another person to have sexual intercourse against his or her will, using manipulation, physical force, threat, or bribery.

Examples: Rape; forcing the performance of sexual acts that cause discomfort or repulsion; preventing use of contraceptive methods; forcing abortion; forcing marriage, pregnancy or prostitution; limiting or nullifying a woman's exercise of sexual and reproductive rights.

THE **CICLE** OF VIOLENCE AND ITS IMPACTS

Phase 2

REGRET

It corresponds to the aggressor's explosion, in other words, the lack of control reaches its limit and leads to the violent act. Here, all the tension accumulated in Phase 1 materializes in verbal, physical, psychological, moral, or property violence.

Phase 3

This is characterized by the aggressor's repentance and becoming kind in order to achieve reconciliation. The woman feels confused and pressured to maintain her relationship, giving up her rights and resources, while he says he will "change".

TENSION-BUILDING

Phase 1

The aggressor is tense and irritated by insignificant things, the aggressor has fits of rage, humiliates the woman, makes threats, and destroys objects.

RIGHTS GRANTED TO WOMEN

Understanding the Laws:

Law No. 11.340, of August 7, 2006 Maria da Penha Law

The Maria da Penha Law was sanctioned on August 7, 2006, and creates mechanisms to prevent and confront domestic and family violence against women in accordance with the Federal Constitution (Section 226.8).

Law No. 12,845/2013 and Decree No. 7,958/2013 Health Care

Provides for the mandatory and comprehensive care of people in situations of sexual violence. It establishes guidelines for the care of people in situations of sexual violence by public safety professionals and the Unified Health System care network.

Law 13.104/2015 Feminicide

Amends section 121 of Decree-Law nº 2.848, of December 7, 1940 - Penal Code, and section 1 of Law nº 8.072, of July 25, 1990, to provide the feminicide as a qualifying circumstance of the crime of homicide and include feminicide in the list of heinous crimes.


HOW TO **REPORT**? Central **180** and Dial **100**



The Central de Atendimento à Mulher (Women's Call Center) is a nationwide service, created to combat violence against women and offers three types of service: registrations of complaints, orientation for people in situations of violence, and information about laws and campaigns. It provides information about the network of attendance in the women's municipality.



Disque 100 (Call 100) receives, analyzes and forwards reports of human rights violations related to the following groups and/or themes: children and adolescents, elderlies and people with disabilities.
